**All players must read each section and initial at the end of each section to acknowledge that they have read, understand, and agree to abide by said term of registration.**

**1.The player understands and agrees that the sport of ice hockey has inherent physical dangers which may result in serious injury and/or death.** The player assumes all of the risk of personal injury which may result from participation in activities of the Coast Hockey League , hereafter referred to as the 'CHL'. The player will not hold the CHL, any of the CHL officials , management, owners, nor the proprietor or employees of any ice facility used by the CHL liable for injury which the player may sustain while participating in any league activity.

2.The player understands and agrees that he is responsible for any and all medical costs arising from any injuries received while participating in any CHL activities. INITIAL \_\_\_\_\_

3.The player certifies that he has no known medical condition which would prohibit him from participating in the sport of ice hockey. **The CHL strongly recommends that each player receive a physical check-up before beginning participation in any league event.**

4.The player agrees to wear a C.S.A. approved protective helmet at all times that he is on or near an ice surface during any CHL activity. This shall include but not be limited to warm-up, breaks in games, while on the bench, and during post game hand shakes. The player understands that he may be subject to suspension and/or expulsion for violation of this rule. **For reasons of safety the league strongly recommends that all players wear an approved full facial mask.**

5.The player agrees that he will act in a mature and responsible manner in all league activities which he participates in. The player understands that any behavior which the management of the league deems to be irresponsible will result in the player's immediate expulsion.

8. The player understands the registration payment installments are due on May 1<sup>ST</sup> and June 1<sup>st</sup>. The player understands and agrees that in the event that he is delinquent in his payment to the league, his continued participation in any league activities will be conditional upon payment of late fees in the amount of (15%) per month for each month or portion thereof that he is delinquent. Further, the player understands that he will be charged \$25 for any check submitted as payment to the CHL which is returned because of insufficient funds, and that his continued participation in any league activities will be conditional upon payment of these funds. In the event that the player has not provided the league or his coach with post-dated checks for full payment on or before the said payment deadlines, he is required to provide a credit card number which he agrees will be billed on May 1<sup>ST</sup> and June 1<sup>st</sup> if he is deemed to be delinquent in payment.
